On March 14, Mr Yeung attended the 2025 iPitch Competition hosted by the Junior Hong Kong-Canada Business Association (McGill Chapter) in Montreal. Through this annual competition supported by HKETO and InvestHK, participating students pitched their business ideas in teams to win a prize.

Speaking at the event, Mr Yeung updated the young talents on the business environment and advantages of working in Hong Kong. Noting that many Canadian financial institutions have a long presence in Hong Kong, he highlighted the strong ties between Hong Kong and Canada, and encouraged the young Canadian talents to consider Hong Kong as the destination to launch their careers.

High marks for Hong Kong's university degree courses

Hong Kong has emerged as the world's "most improved" location for university degree courses, reflecting the determination of the Hong Kong Special Administrative Region (HKSAR) Government to develop the city into an international education hub with strong emphasis on nurturing talents in innovation and technology.

The 2025 QS World University Rankings by Subject rated six local degree courses among the world's top 10, up from three last year, while 68% of 231 programmes from nine Hong Kong institutions rose in the rankings.

In the field of data science and artificial intelligence (AI), five Hong Kong universities are ranked among the world's top 50, the highest number in Asia and second-highest globally.

This demonstrates the city's immense potential and competitiveness in technological innovation, providing crucial support for the city's development. The HKSAR Government has also rolled out various supportive policies and initiatives to attract talent and businesses to Hong Kong to participate in marketization and innovation.

This year's ranking compared over 21 000 academic offerings at more than 1 700 universities across 100 countries and territories in 55 subjects.

Kai Tak Sports Park Grand Opening Ceremony held

The Grand Opening Ceremony of the Kai Tak Sports Park (KTSP) at Kai Tak Stadium was officiated by the Chief Executive of the HKSAR, Mr John Lee, on March 1. The KTSP is the largest sports infrastructure project ever commissioned in Hong Kong. It will boost sports development and inject impetus into related industries such as recreation, entertainment and tourism, and also mega-event economy, thereby consolidating Hong Kong's reputation as an event capital in Asia.

The KTSP provides modern and multi-purpose sports and recreation facilities, including a 50 000-seat Kai Tak Stadium, a 10 000-seat Kai Tak Arena and a 5 000-seat Kai Tak Youth Sports Ground. There are also over 700 000 feet of retail, catering as well as leisure and entertainment facilities in the KTSP, providing a one-stop sports, leisure, catering and shopping experience for citizens and tourists, as well as the necessary hardware for driving the development of sports and the relevant industries.

Conference on Climate Change and International Trade Law held in Hong Kong

The Conference on Climate Change and International Trade Law was held in hybrid format in Hong Kong on March 14. Jointly organised by the United Nations Commission on International Trade Law and the Hong Kong International Legal Talents Training Academy of the Department of Justice of the HKSAR Government, the Conference discussed how the international trade law could effectively support the achievement of climate action goals set by the international community.

The Conference attracted about 600 registrations from around 70 jurisdictions in Asia-Pacific, the Middle East, Latin America, Europe and Africa. Prominent speakers from around the world joined the panel discussions. Participants from diverse backgrounds and sectors, including academics, judges, officials, legal and dispute resolution professionals, as well as other professionals and representatives from international organisations, shared their insights on a variety of topics on climate change and international trade law.

The HKSAR Government invites proposals for admission to third InnoHK research cluster

The Innovation and Technology Commission of the HKSAR Government announced on March 14 an invitation for proposals for admission to the third InnoHK research cluster, SEAM@InnoHK, focusing on sustainable development, energy, advanced manufacturing and materials. The global top echelon of universities/research institutions in the relevant fields are welcome to apply.

Following the setting up of the first two research clusters, namely Health@InnoHK, focusing on healthcare technology, and AIR@InnoHK, focusing on artificial intelligence and robotics technologies, the HKSAR Government is taking forward the establishment of the third InnoHK research cluster, SEAM@InnoHK, which will enable Hong Kong to move full steam ahead towards becoming a global research collaboration hub.

The selected research centres/laboratories should conduct collaborative research that is innovative, world-class, of global relevance, and addressing real-world problems in collaboration with world-renowned non-local universities and research institutions. Collaboration between local universities/research institutions is also highly encouraged.

CMU OmniClear and HKEX sign MOU on enhancing post-trade securities infrastructure of Hong Kong's capital markets

CMU OmniClear Limited (CMU OmniClear), a wholly-owned subsidiary of the Exchange Fund, and Hong Kong Exchanges and Clearing Limited (HKEX) signed a Memorandum of Understanding (MOU) on March 4 to deepen their collaboration in enhancing the post-trade securities infrastructure of Hong Kong's capital markets, and supporting the long-term development of the city's fixed-income and currencies ecosystem.

Based on the MOU, CMU OmniClear and HKEX will explore and pursue cooperation in areas such as realising cross-asset class efficiencies across equities and fixed income, expanding the use of Mainland bonds as collateral, enhancing Hong Kong as a bond issuance centre and developing an international central securities depository in Asia, with a view to consolidating and enhancing Hong Kong's status as an international financial centre, a global risk management centre, and an offshore Renminbi business hub.
