### Hong Kong hosts first 6G Global Summit in Asia-Pacific region

The two-day 6G Global Summit, held in a hybrid format for the first time in the Asia-Pacific region, concluded on May 9 in Hong Kong. Hosted by the Communications Authority with the support of the Hong Kong Special Administrative Region (HKSAR) Government, the Summit attracted over 600 participants from more than 80 countries. Attendees included high-level representatives from policymakers, regulatory bodies, international organisations, telecommunications operators and corporations, as well as industry experts and scholars. They explored the potential of the sixth-generation (6G) mobile communications technology in shaping a better future.

In his keynote speech at the Summit, the Secretary for Commerce and Economic Development of the HKSAR Government, Mr Algernon Yau, highlighted Hong Kong's highly acclaimed position in leading the development of 6G. He also shared with the

audience Hong Kong's various achievements in telecommunications, which showcase the city's readiness to embrace the future of telecommunications.

Over the two days, the Summit also featured discussions on the key priorities shaping 6G developments, including standardisation, technological innovations, sustainability and potential applications, as well as the strategic role of the Asia-Pacific region and the opportunities presented by a more connected and intelligent global network.

## Financial Secretary attends Asian Development Bank Annual Meeting in Milan, Italy

The Financial Secretary of the HKSAR, Mr Paul Chan, arrived in Milan, Italy, on May 4 to attend the 58<sup>th</sup> Annual Meeting of the Asian Development Bank (ADB). The theme of the meeting is "Sharing Experience, Building Tomorrow", focusing on development issues and challenges facing the Asia-Pacific region, such as climate change, digital transformation, and promoting mutually beneficial co-operation and inclusive economic growth.

Speaking at the Business Session and the Governors' Plenary at the ADB Annual Meeting, Mr Chan highlighted that under "one country, two systems" principle, Hong Kong maintains its status as a free port, implements free trade policies and ensures the free flow of capital, goods, people and information. He reiterated Hong Kong's steadfast support for a rules-based multilateral trading system. As an international financial centre, Hong Kong is willing to share experiences in innovative financing arrangements with ADB members, including infrastructure loan securitisation and catastrophe bonds, to support high-quality infrastructure and green projects.

Mr Chan also met with the President of the ADB, Mr Masato Kanda, and financial officials from other countries and regions attending the meeting. They exchanged views on the international economic landscape.

# Import of poultry meat and products from Rural Municipality of Wallace of Manitoba Province in Canada suspended

The Centre for Food Safety (CFS) of the Food and Environmental Hygiene Department of the HKSAR Government announced on May 13 that in view of a notification from the World Organisation for Animal Health about an outbreak of highly pathogenic H5N1 avian influenza in the Rural Municipality of Wallace of Manitoba Province in Canada, the CFS has instructed the trade to suspend the import of poultry meat and products (including poultry eggs) from the area with immediate effect to protect public health in Hong Kong.

According to the Census and Statistics Department, no poultry meat and eggs were imported into Hong Kong from Canada in the first three months of this year.


